

Survey of Local Elected Officials Codebook

The codebook is used as a reference to interpret the layout of the data file. It provides a list of all the survey questions and the numeric value of each answer option.

Please note: Questions in the data file with cells that have no value (blank) indicates the respondent was either not shown the question (due to skip logic) or chose to not answer the question. Questions in the data file with cells that have a value of -99 were displayed but are unanswered.

Questions of the type "select all that apply" list a "1" or "0" for each possible choice for that question, with each checkbox having its own variable. The suffix "1" indicates "checkbox 1", "2" for "checkbox 2" and so on. For instance, a variable named "Q10_1" refers to the first checkbox for Q10.

Questions of the ranked type which ask for less than choices to be ranked than the total amount of choices (ex. ranking 3 of 5 choices) use a 0 to indicate if a choice went unranked.

CASEID

A unique identifying number assigned to each record (respondent).

USERLANGUAGE

Language that was used by respondent at the start of the survey.

DISPOSITION

Complete or partial (S1=1 and S2=1).

Embedded data assigned to each record by the research team.
